THERE ARE NO REFUNDS ON EXHIBITOR CANCELLATION 30 DAYS PRIOR TO SHOW DATE. VENDOR WILL BE RESPONSIBLE FOR PAYMENT OF SHOW. NO REFUNDS FOR RAIN DATES. EMERGENCY CANCELLATIONS WILL BE HANDLED APPROPRIATELY. FEES CAN BE CHANGED AT ANY TIME. **THERE IS NO VERBAL SIGN UP ALL MUST BE ON AN APPLICATION.** No deposit is transferred or refunded for cancellation.

NO SALE, HAND WRITTEN, OR SHOW SPECIAL SIGNS ARE PERMITTED.
